Changes to Mail Procedures

Starting November 1, 2024, all general correspondence and envelopes will be photocopied with only the copies being provided to the inmate population. All originals correspondence will be kept for 30 days and destroyed after the 30 days.

You will be proved a black & white photocopy of all written mail. You will be provided a black white photocopy of all greeting cards.

All incoming general correspondence envelopes and paper must be white in color.

 Incoming correspondence may not contain materials such as glitter, stickers, lipstick, crayon, or marker. Correspondence may not be stained or contain an oily substance. These items will be rejected and not copied.

Photographs will be copied and processed under the same procedures. Photographs that do not comply with policy will be rejected and will not be photocopied.

 Family photographs are the only correspondence that will be copied in color.

All incoming special and legal mail will continue to be opened only in the presence of the inmate; however, envelopes from incoming special or legal mail will be photocopied prior to delivery, with only the copy provided to the inmate.
